PART 1 – OPEN SESSION

PET104/14 PUBLIC FORUM

There were no members of the public present.

PET105/14 APOLOGIES FOR ABSENCE

Apologies of absence were received from Councillors Ginn, Senior, and Wassell.

PET106/14 APPROVAL AND SIGNATURE OF MINUTES

The Minutes of the meeting held on 13th February 2014, having previously been circulated, were approved and signed by the Chairman as a true record.

PET107/14 CHAIRMAN'S ANNOUNCEMENTS

(a) Update from Councillor Rickett regarding Horsham District Council's meeting of 13th February 2014.

Councillor Rickett commented that the meeting, a follow up after the recent public consultation on development proposals, was very heavily attended and gave the opportunity for 10 questions from the public. These were pre-selected prior to the meeting and concerns were again raised over such issues as lack of infrastructure and the need to preserve the strategic gap. Three presentations were also given, and included a traffic survey report which found that there would be no impact on the number of AM traffic movements, but when asked about PM figures, these were not available. The issue of the proposed large business centre was also raised by HDC Councillors, as there was sufficient empty office space in the town already which is the cheapest in the County and still cannot be filled. Further, that research shows that approximately 40,000 people leave the Horsham District for work each day with 25,000 staying with the Gatwick Diamond area, whereas only 5,000 people come into the Horsham

District for work. The outcome of the public consultation should be delivered at an HDC meeting in late April, with the date yet to be finalised.

(b) Request for Temporary Traffic Regulation Order – Kings Road Roundabout

Members noted the request for a Temporary Traffic Regulation Order for the closure of Kings Road Roundabout at its junctions with Parsonage Road, Rusper Road, Crawley Road and Redkilyn Way to allow for carriageway resurfacing, for 5 weekday nights beginning 7pm on Thursday 24th April 2014. The closure will be effective between 7pm to 6am each night and will remain open Saturday and Sunday night.

(c) Request for Temporary Traffic Regulation Order – North Heath Lane / Wimblehurst Road

Members noted the request for a Temporary Traffic Regulation Order for the closure of North Heath Lane / Wimblehurst Road between its junctions with Richmond Road and Giblets Way to allow for carriageway patching to be carried out, for 5 days beginning Monday 24th March 2014.

(d) Request for a Temporary Traffic Regulation Order – Parsonage Road

Members noted the request for a Temporary Traffic Regulation Order for the closure of Parsonage Road at its mini roundabout with Foundry Lane and Parsonage Way in order to allow for carriageway resurfacing to be carried out for 3 nights beginning 7pm Wednesday 30th April 2014. The closure will only be effective between 7pm and 6am each night.

PET109/14 TO DISCUSS PLACEMENT OF BOLLARDS AT LAMBS FARM ROAD JUNCTION WITH GREENFIELDS ROAD

Members noted that WSCC had now confirmed that approximately half the required funding for this project had been secured already, and this was based on a quote for a plan produced by WSCC. This would also mean the work would likely be carried out by WSCC contractors rather than the Parish Council's.
