PET/099/15 PUBLIC FORUM

There were two members of the public present. Mrs Glennon commented on the lack of consultation from Horsham District Council (HDC) regarding the granting of an Alcohol Licence in respect of the proposed Sainsburys store to be opening at Horsham Floorings and Furnishings. She further commented that HDC had not consulted at all about the two planning applications relating to the site. She further commented on noise, traffic and anti-social behaviour issues that may arise following the opening of the store.

Mr Chirag commented that, as a small business owner, he was extremely upset and concerned at the opening of the Sainsburys store. He further commented on the impact of noise and traffic issues.

The comments of the residents were discussed and it was agreed that the Parish Council's Planning Committee would facilitate a meeting between the local residents and the four District Councillors (Councillors Britten, Cornell, Dancer and Torn) on Wednesday 27th January 2016 at 7.45pm, to enable residents to express their concerns.

(b) Former Evelyn Lancaster House

It was noted that HDC were unable to enforce the wishes of the Parish Council as the naming was of a building and there was no conflict with any other building with a similar name in the surrounding area.
