#### 4. Chairman's Announcements

##### a) Public Rights of Way Routine Maintenance

Members are asked to note the summary of works undertaken in the Parish during the recent routine maintenance: 142 metres of vegetation clearance. The next scheduled maintenance will be in nine months time.

##### b) Request for Temporary Traffic Regulation – Pondtail Road

Notification has been received from WSCC of a proposed Temporary Traffic Regulation Order to allow investigative works on the bridge to be carried out safely, for one night beginning 10pm Tuesday 2<sup>nd</sup> December 2014.

#### 6. To discuss street naming – Development at Littlehaven Lane/Crawley Road

Horsham District Council is seeking comments and suggestions on the naming of the new development on the corner of Littlehaven Lane and Crawley Road. The developers have put forward a suggestion of 'Haven Court' or 'Anchorage Court', but are open to other suggestions.

**7. To consider an Operation Watershed application for a replacement French drain – St. Robert Southwell Catholic Primary School**

County Councillor Jim Rae has requested that the Parish Council, as the most appropriate local body, front an Operation Watershed application of around £12,500 on behalf of St. Robert Southwell Catholic Primary School and residents of No.s 8, 10, 12 and 14 Amberley Road. There is currently an inadequate French drain in place at the lower end of the School's playing field which was incorrectly installed and causes flooding on the playing field with run off into the adjacent properties on Amberley Road. This has been a problem for more than 20 years, and the only solution is for the complete removal and replacement of the drain. Further information will be provided at the meeting.
