4. Chairman's Announcements

a) **Airport Commission consultation regarding second runway at Gatwick Airport**

Members are asked to note that following on from the previous Committee meeting and the comments from local residents, a public meeting on this issue has now been arranged to take place on Tuesday 13th January 2015 at 7pm at North Heath Hall.

5. **Declarations of Interest**

If the interest is a Disclosable Pecuniary Interest, Members are reminded that they must take no part in the discussions of the item at all; or participate in any voting; and must withdraw from the meeting chamber; unless they have received a dispensation.

6. **To consider request regarding the Bus Stop and Bus Shelter opposite Chesterton Court, Manor Fields**

Members are asked to note that following the last Committee meeting, a letter was sent to Metrobus to request the moving of the bus stop signage to be adjacent to the shelter. Metrobus responded by confirming they would be happy to do this, but it would require WSCC to install the pole for the signage to be attached to. WSCC have therefore been contacted to request this.
