4. Chairman's Announcements

a) Request for Temporary Traffic Regulation – Parsonage Road Level Crossing

Notification has been received from WSCC of a proposed Temporary Traffic Regulation Order to allow for essential maintenance, for one night beginning 17th January 2014.

b) Public Rights of Way Routine Maintenance

Members are asked to note the summary of works undertaken in the Parish during the recent routine maintenance: 3 repaired waymarkers. The next scheduled maintenance will be in nine months time.

5. Declarations of Interest
