# 9. HDC Polling District and Place Review 2023

HDC have announced that a Statutory review has begun of polling districts and polling places and they welcome the Parish Council's comments on the proposed changes. Please see their website for full details of the proposals (www.horsham.gov.uk/pollingstationreview), noting there that are proposed changes to some polling places (detailed on this webpage - <u>Schedule of Polling</u> <u>Districts and Polling Places</u>).

A polling place is the building or area designated by the Local Authority, within each polling district, in which polling stations will be located by the Returning Officer. The polling station is the room or building where polling takes place. Sometimes it may be necessary for two polling stations to be located in one building or for a polling place to be outside the polling district if no suitable venue can be found. Their main aims are to ensure that all electors in the local authority area have such reasonable facilities for voting as are practicable; and so far as is reasonable and practicable, polling places are accessible to all electors including those who are disabled.

Comments and alternative suggestions made as part of this consultation will be considered and included in a report to the Governance Committee on 27 November. The Governance Committee will make recommendations to the Council meeting on 13 December, who will set the revised scheme of polling districts and places until the next review.

The consultation period closes on 30 October and all responses to the consultation will be published, as required by the legislation.
